Approval of Meeting Minutes: On a motion by Joe Claar(2nd, Alex Musselman), the Supervisors approved the January 3, 2023, Reorganizational & Regular Meeting minutes as presented.

Bid on Used 2009 Masey Ferguson Tractor with Boom: On a motion by Alex Musselman (2nd, Joe Claar), the Supervisors voted to bid on the Tractor through Municibid and the bid is not to exceed \$50,000.00. *(Greenfield Township was not the high bidder and therefore will not be purchasing the tractor.)

American Rescue Plan Funds: The Board asked for a list of the non-profits that they gave first round donations to. They agreed to re-visit second round donations in March or April. No action taken.

Update pricing on cage and net for batting cages: On a motion by Joe Claar (2nd, Alex Musselman), the Supervisors amended the motion from the November 1, 2022 meeting for purchasing batting cage nets and poles from Jones Sports. The amended motion is to remove the netting and poles and replace it with a commercial grade batting cage kit with everything included.

Community Center Floor Waxing: On a motion by Joe Claar (2nd, Alex Musselman), the Supervisors voted to have Premier Cleaning and Restoration strip and wax the Community Center floors for a quoted price of \$1,175.00.

The Claysburg Kimmel School District can then work with the Little League around their schedule of use of the field.
